

Bird Gang Getaway Sweepstakes (“Promotion”)

Official Rules

NO PURCHASE NECESSARY TO ENTER OR TO WIN. VOID WHERE PROHIBITED.

ELIGIBILITY: The Promotion is open only to individuals who are 18 years of age or older at the time of entry and legal residents who live, work or worship in of the State of Arizona, excluding the counties of Greenlee, Santa Cruz, Apache and Graham.
